Applicant must submit a current "Certificate of Good Standing" issued by the Colorado Secretary of State and Articles of Incorporation including a list of the entity's officers/directors/stockholders, demonstrating who has the ability to bind the entity.

⁴ If applying as a partnership, applicant must submit the Articles of Partnership indicating the General Partners.

⁵ If applying as a trust, applicant must submit the Declaration of Trust indicating the Trustee.
